## CELEBRATING 150 AT ALL SAINTS PARISH, BEDFORD

## REPORT TO 2019 ANNUAL MEETING FOR THE PARISH

Parish Council established a working group to celebrate the 150<sup>th</sup> Anniversary of All Saints Church. The purpose of the working group was to arrange activities that would celebrate the history of our Parish and Church and would help provide a vision for the future. Fred French undertook primary responsibility for the celebration while Rev. Trevor Lightfoot undertook primary responsibility for the visioning and discernment activities.

In addition to celebrating our accomplishments and our fellowship, we wanted to acknowledge our past, to respect our heritage and to look to the future by joining with the visioning task. Associated goals were to build awareness of All Saints in the community, to grow our community recognition, and to engage with greater numbers of people. Part of the strategy in undertaking this was to raise our profile in the community, in the media, in local government and with selected community groups to engage in further self help projects. Our goal was to integrate activities that already formed a part of our Parish with some new activities. A brief list of some of the activities follow:

- Opening blessing & dedication on November 4, 2018 .. All Saint's Day .. media coverage including invited guests such as Tim Outhit. Focus was on what All Saints means to me ... released the 150<sup>th</sup> prayer.
- November, 2019 held Christmas Dinner and Choir Performance .. a regular event integrating usual activities and promotion of the 150<sup>th</sup>.
- February, 2019 held usual Men's Brunch & integrated 150<sup>th</sup> ....
- March, 2019 held our usual Pancake Supper
- 5. April 28, 2019 held our Annual Appreciation Luncheon & 150<sup>th</sup> cake with C & C Group
- May 25, 2019 held our first Jiggs Dinner and Newfie night featuring food, music, fun, refreshments
- 7. May/June, 2019 Began preparing our Church Directory
- 8. May 30, 2019 held first of series of Boxwood Musical Performances
- 9. June, 2019 held the usual Lobster Take Out
- 10. July 30, 2019 held the second in a series of Boxwood Musical Performance
- 11. September, 2019 held the usual Back to Church event
- September, 6, 2019 osted the Erma Bombeck Play .. had to cancel performances due to weather .. rescheduled for June, 2020
- 13. November 3<sup>rd</sup>, 2019 held our Anniversary Service and Community Gathering featuring special guests, a celebration of groups with whom we work, special greetings from the City and Government and other partners
- 14. Christmas Eve Services, 2019 .. Conducted a Survey with persons who attended services on their expectations and wishes regarding services & programs by All Saints
- 15. January 18, 2020 hosted a Community Forum for Seniors featuring a variety of speakers on family, nutrition, keeping active, legalities and well being & healthy aging.

Conducted a survey on desired services and follow up activities which are now being planned ...

16. Continuing ... to follow will be a Survey for Parishioners on Visioning

We set out to host about 12 activities or one per month. While that was ambitious, we actually held more activities than originally planned thanks to many volunteers. However, we also made changes in some of our plans based on feedback and interest. For example, we moved some events to the new year due to having too much to do in a short period of time. This was a positive as it resulted in more engagement and helped us transition to future goals such as our interest in developing the beginnings of a potential plan to support community based forums and perhaps services for seniors. We also changed from a dinner to a community based Celebration Service to align with our Anniversary Celebration as this was more in line with the wishes of Parish members and our funding needs. In a way, rather than invest in a dinner on a personal and Church level that change probably contributed to increasing our Anniversary Fund Giving by about \$5000 for the Church. As well, we were successful in linking from our past to where to in the next 150 years.

Some activities are still progressing such as our Directory which should now be ready in March. As well, our Memory Book has been separated from our Directory and will be a separate publication for June/July featuring pictures, stories and what All Saints means to me. We had a tremendous amount of contributions to this idea. We've also held back on our Children's Book to incorporate some additional All Saints material that wasn't in the original conception. The play about Erma Bombeck which had to be cancelled mid run due to a fall storm has been rescheduled to June, 2020.

Overall, this was a positive experience and one of growth as well as celebration. We learnt a lot, listened to suggestions for change and achieved greater awareness of our work with the City and Government and are planning to pursue some further possible grants, and we established a media presence with a positive article in the Herald and Diocesan Times. We did not spend any money aside from that raised to host events and in turn contributed about \$6000 to the budget. Thank you to a tremendous number of volunteers and to all the members of the Parish who contributed and participated.

## Rector's Report for the Year 2020

"Therefore, since we are surrounded by such a great cloud of witnesses, let us throw off everything that hinders and the sin that so easily entangles. And let us run with perseverance the race marked out for us,..." Hebrews 12:1

## Dearly Beloved,

Wow, how does one write a report for the year 2020, where does one even begin? It truly has been a year like no other for many of us, and just like many businesses and organizations the Church found itself thrusted into uncharted waters to navigate. Our response required a lot of creativity, ingenuity, and prayer to maintain, adapt, and enhance the worship, ministry, and outreach of All Saints. We were only able to achieve what we achieved through your gracious acceptance, understanding and patience, as well as your ideas, suggestions, support, and your personal commitment to your faith and All Saints. Has everything gone just as planned? Or has everything turned out perfect? No. But I am proud of what we have been able to accomplish to this point with the limited resources available to us.

2020 started normally enough. We had just finished a year of Celebrations marking our 150<sup>th</sup> in 2019, and we were moving into 2020 with big plans to focus on developing our vision and strategic plan for the parish. On the 8<sup>th</sup> of March we had a wonderful celebration of confirmation as 8 individuals were confirmed by Archbishop Ron. Then it happened, the coronavirus was declared a worldwide pandemic, and everything changed.

On March 15<sup>th</sup>, 2020, All Saints' Executive and some staff met to discuss the developing situation regarding Covid-19. The result of that meeting was a unanimous decision to suspend in person worship until it was deemed safe to gather once again. On March 16<sup>th,</sup> an official directive came from the Diocese, in response to the announcement of Provincial restriction, that all parishes in the Diocese were to suspend worship from that point forward. As well as determine how our facilities would operate under the restrictions posed by the provincial government. One of All Saints' first responses to all of this was the establishment of our own Covid-19 Response Team, made up of Clarence Hewitt and Bob Attenborough (Parish Wardens), Sandra Peterson and Fred French (members of parish council with expertise in Health Care), and me as Rector. I am very grateful for this group of people. This group has worked hard to provide direction for our community regarding gathering and the use of our facility. While not all this group's decisions have been popular with everyone, I can assure you that every decision made was with concern for everyone's health and safety in mind. We tried to live out the Gospel, by loving our neighbours as ourselves.

The first few Sundays following us suspending worship we attempted to live stream services to Face Book, YouTube and Twitch. Unfortunately, due to older, insufficient, equipment and an overtaxed internet we had a rough beginning with our streams cutting out or stopping completely on us. As a result, we moved to producing a pre-recorded service that

we posted on Facebook and You Tube. This delightfully allowed us to incorporate the participation of others, by way of readings and leading the prayers of the people. To all those who offered their time to record themselves doing a reading or leading the prayers, THANK YOU. Your contributions were a welcomed addition and, I think, helped in us feeling connected.

For Holy Week we provided a combination of "online in person worship" using the platform Zoom as well as pre-recorded services. It was not optimal but given the circumstances of what we were all experiencing, it held its own sense of Reverence and Holiness.

As the summer months rolled around the restrictions around faith gatherings were eased and allowed us to begin contemplating gathering and worshiping in person. For July and August we decided to hold two outdoor services on our cemetery grounds. Then in September we moved back into our facility for in person worship. Since we were only allowed to have 50% of our seating capacity up to 100 individuals gathered while adhering to social distancing rules our Covid-19 Response team made the decision to begin holding our worship in the parish hall. There were various reasons for this, 1) 50% capacity in the church and the hall was roughly the same, 2) Using chairs that were appropriately place six feet away from one another helped to manage the compliance regarding social distancing, 3) worshiping in a large open space, with fewer nooks and cranny's to be concerned with ensured for a more thorough and quick cleaning following each service. This last item was important as we relied on volunteers who were attending worship to help clean following the worship. Although we were once again worshiping in person we also continued to record and post our services on Facebook and You Tube realising that there were still many that were not comfortable gathering in person for worship.

We continued to worship in the parish hall until December when the Provincial Government once again tighten restrictions causing us to again suspend in person worship. This time the scramble was real and intense as we looked at ways to provide for Christmas Eve services, for the plans that the worship committee had been working on got completely sidelined by the new restrictions. In the end we were able to produce a pre-recorded family service, for which we have received a lot of positive feedback, as well as live streamed a more traditional service with in- person participation by the parish leadership and some pre-recorded material provided by others. I must also mention that the tighten restrictions imposed in December meant that we would miss an in-person worship for our white gift Sunday. We did not let these restrictions stop us though. We set up a collection for white gifts in the parking lot for two days. As in years past I was overwhelmed with joy at the number of items that there were donated for white gift Sunday. I am so proud of our community and that fact that we have not allow the conditions of Covid-19 to diminish our generosity and outreach ministries.

In attempts to stay connected we added a few elements to our daily parish life. We began hosting an Evening Prayer on Sunday nights via zoom, which has been coordinated and led by Graham Lavers one of our Licensed Lay Leaders (LLL). We also offered a service of compline/night prayers on Monday, Tuesday, and Wednesday nights. The leading of these services was shared between the Rev. Shirley, Sue Burbury (LLL), Fred French (LLL) and me. These services were also offered via the platform zoom and we normally had 6 plus in attendance. We also offered from March until July a Sunday meet and greet at 11:00 am. This was a wonderful time of connecting with folks in person while we were all in "lock down." For

a few months we also moved our Christian Meditation, led by Mary Leigh (LLL), to online. As well during Advent, I offer what I entitled "Story Time with Rev. Trev." This was a recording I did each day of me reading from an Advent Children's book and posting to our social media accounts. I was pleasantly surprised to receive just as many comments from adults who tuned in daily as I had from parents with children.

During 2020 we also tried on a few occasions to offer opportunities for families and young children. We tried to do a few before service children's time online, as well as an online Messy Church. Unfortunately, none of these were well attended. This however has not discouraged us and there are more plans underway to attempt to connect with younger families and children. Any suggestions would be graciously received.

While most of what I have written thus far has been center around worship that does not mean that this was the only thing happening at All Saints. In many respects during this time, it has been business as usual, not normal by any means, but as usual. Our two main study groups, Faith Explorers and Bible Exploration, continued to meet regularly via the Zoom platform. Parish Council, the Worship Committee and the Visioning and Discernment group, all continued to meet regularly by electronic means. Also our Director of Music, Gillian, coordinated regular electronic gatherings/practices for the Choir.

Another area of great concentration during this time was in pastoral care. following the province placing us under a state of emergency and accompanying lock down, the Rev. Shirley assembled a team of callers. Our parish list was divided, and each caller was assigned a group of folks to check in with on a regular basis, unless the person receiving the call stated otherwise. To Flo Price, Clarence and Linda Hewitt, Graham Lavers, Henrietta Munro, Dianne Nickerson, Marlene Lelacheur, Jill Greenham, Ruth Elford, Sandra Peterson, Ena Keast and Sharon Burrows, thank you for giving of your time to check in on your fellow All Saints parishioners. As many of you know this is was a particularly difficult and painful year for anyone suffering a significant illness or losing a loved one. There was a lot of time spent on the phone by Rev. Shirley and me reaching out to offer care to those experiencing a particularly difficult time. As a community we also experienced the pain of two significant loses. Cheri Winters, a long-time member of All Saints and daughter of a family with a long-time connection to All Saints and deep roots within the Bedford community, and Dr. Warren Ervine, long time parishioner, Licensed Lay Reader, and faithful servant in many ways, both died in 2020. Thankfully as restrictions were eased, we were able to Celebrate their lives with graveside services within our Parish Cemetery.

2020 also brought an interesting twist to our ordained leadership team. In May the Rev. Shirley was asked to take the position of Priest in Charge of Western Shore. Even when the Rev. Shirley was a student here at All Saints she always expressed that she felt her ordained ministry was to be lived out in a team ministry within a parish AND when needed by the Diocese to help assist in other parishes that may be in short term need of a priest. Therefore, this opportunity was a perfect fit for the Rev. Shirley and living out the vision of her ministry. So, in June of 2020 the Rev. Shirley began her interim ministry until the end of Oct. During the months of Nov. 2020– Jan. 2021 the Rev. Shirley took a much deserved three month leave. While we excitedly awaited her return, God via the Dioceses came calling again and the Rev.

Shirley has accepted another interim ministry as Priest in Charge of a parish in Dartmouth. The nice thing about this arrangement is that the Rev. Shirley is only obligated to provide Sunday worship 3 times a month and she has promised that we will see her from time to time on those Sundays she has off.

In closing there are a few things I would like to offer comment on. First, I want to commend Parish Council in the decision they made in November to purchase some appropriate equipment to enhance our online presences. I think it is safe to say, and important to say, that in addition to the way things are normally done the offering and conducting church by electronic means is here to stay. If you would like to help enhance this experience either by way of financial support or offering your time, please let me know. Currently we have only one producer, director, and camera operator, which is Braeden Lightfoot whom I wish to say a huge thank you to for all the effort he has put in to help see our online presence grow. As mentioned above if you, or you know someone who might like help in a hands-on manner, please let me know. An increased online presence can have major benefits for a parish. You will hear many faith communities remark that they are connecting with folks from all over the world since going online, which is also true for us! As well, being able to offer the use of this equipment during weddings and funerals opens other possibilities that could benefit the parish. If you have any comments or suggestions in how we might enhance our offerings electronically, please do not hesitate to share. One of the challenges I have been trying to figure out, is how can we help those of our community who are not tech savvy, or don't have the equipment to make use of our electronic offerings?

Second, I wish to offer a brief comment on our financial situation. As we are all aware 2020 was challenging in many ways, but as I have said from time-to-time 2020 has also produced a lot of positives. One of those areas where I have seen the positive is in relation to our financial situation. Once again for the 2020 we had budgeted for a rather large deficit, realizing this also meant we would not be able to contribute our fair share to the Diocese by way of allotment. It is not something I, nor our council, were happy about but it is the reality we live with until we begin to see some fruit of the labours of our Visioning and Discernment Group. Thankfully, things did not turn out as bad as we had projected for 2020. Part of this was due to the Diocese stepping up and covering the salaries of Rector's across the diocese for a few months as well as suspending some allotment payments. Another part of it was that many of you were able to, and committed to, maintaining a regular offering which we are incredibly grateful for, thank you! As we move forward however, I am wondering if we all might take some time to consider our offering amount and if we might have a little wiggle room to increase that offering. I honestly believe that over time we can close the gap of our deficit, but it will take all of us working together, offering what we can by way of time, talent and treasurer, for the Glory of God and God's mission.

Finally, I wish to take this time to say Thank You to our staff, Denise, Bill and Gillian, all doing what they could to keep things going during this past year. I am so grateful that we were able to continue to employ our staff during this time, and that any suggestion to the contrary was never raised by anyone! They are very committed and conscientious individuals, and I am grateful for the work they do! As well I wish to thank all those on Parish Council for the time they have offered, their guidance is always of great value, but even more so this year. I want to

say a special thank you to Clarence Hewitt and Bob Attenborough, our parish Wardens. These two gentlemen have served our parish faithfully and diligently, not only this year but for years! Their reward, but our loss, is that both Clarence and Bob will be stepping off council this year. I can not express enough of my gratitude to both men for all they have done and helped with. It is a well-deserved break; thankfully however both have assured me that they will still be around to help in other ways, and I plan to hold them to that! Last, but not least I wish to say Thank You to the Rev. Shirley. We are so blessed by her ministry, and although she was not around much this year as she served in another parish, her continued counsel and collegiality while she was away was immensely beneficial to me.

## Wardens Report 2020

Well, 2020 was certainly a year that probably all of us would like to forget but no doubt will linger in our memories forever. The COVID-19 pandemic caused many deaths and created havoc with daily life in our country and around the world. And here in Nova Scotia, who could ever forget the horror of the carnage inflicted by the gunman in Portapique and across the Province? Closely followed by the tragedy of the military cyclone helicopter crash in the Ionian Sea; the loss of a young child in Truro; the Snowbird jet crash in British Columbia; and in December the sinking of the Chief William Saulis in the Bay of Fundy. Yes 2020 was truly an "annus horribilis." We ask God's blessing on all those who have suffered the loss of loved ones, whether due to the pandemic; as the result of the tragedies noted above; or other personal tragedies known only to those affected. We trust and pray that, with the advent of vaccines, we will return to some degree of normalcy before this new year is out.

As a result of the pandemic, all in-person worship and faith-based activities at the Church were suspended from mid-March to mid-September 2020. Likewise, our facilities were closed to all other user group activities. Nevertheless, we were able to continue to fulfil our mission of 'Reaching out and welcoming ALL to discover God's love in a vibrant and nurturing Christian church family' through the recording and posting online of regular Sunday services as well as offering real time Evening Prayer, Compline and other services throughout the weeks via the online Zoom platform.

Around mid-September, the Provincial pandemic restrictions were relaxed. A COVID-19 response sub-committee of Parish Council developed the necessary re-opening plan and protocols and we were able to open for in-person Sunday services. To facilitate social distancing, necessary cleaning and disinfecting etc., services were held in the Parish Hall. As a result of an up-tick in the number of COVID-19 cases in the Province near the end of November we again closed our facility and reverted to posting Sunday services online. Throughout the whole of this period, evening services continued to be offered online via Zoom. As of the time of writing, we have again resumed in-person services in the Hall, commencing 17th January 2021.

Unfortunately, most other faith-based group activities and gatherings such as the Choir, Messy Church, Vacation Bible School, Coffee and Conversation, Mother's Union, ACW, Tuesday Evenings at All Saints and Compline in the Park were cancelled for the balance of the year. Both of our major fund-raising functions, our annual lobster dinner take-out and our olde fashioned Christmas dinner, had to be cancelled as well.

Similarly, the community groups that use our facilities, including Bedford Players, Boy Scouts, Girl Guides, AA, and First Responders had to curtail their meetings and activities. Our support to a number of other community groups was also limited. However, we were able to collect and deliver stuffing mix for the Beacon House Christmas hampers and prepare and serve a St. George's Dinner at our scheduled date.

Our ordained ministry, spiritual leadership and guidance was again provided by Rev. Trevor, our Rector, and, until late May 2020, by Rev. Shirley, our Priest Assistant. At that time Rev. Shirley was asked by Archbishop Ron to consider serving as Priest-in-Charge of a rural parish in Lunenburg County. After prayerful consideration and discernment, she very strongly felt

that God was calling her and so accepted the appointment, which extended until 31st October 020. Upon completion, Rev. Shirley took a three month break for some rest and recuperation.

The Visioning and Discernment Committee continued its work through the year, although it too was impeded by the pandemic. During the summer of 2020, the Committee conducted a survey of Parish members to determine their perceptions of how the Parish is currently performing and their perceptions of the proposed mission and values statement. The intent is to use the information gained in the survey along with other sources of information to document areas in which the Parish is doing well and any areas in which the Parish can improve its overall performance. Further details regarding the survey and planned future activities of the Committee will be provided in the Committee's report to the AGM.

The Visioning Committee also undertook to completely revamp and replace the All Saints website. We engaged the services of a consultant, who with the assistance and guidance of Amanda Avery and Candice Chapman has created a fantastic new set of All Saints web pages and related content. Amanda and Candice have also agreed to maintain and update the website content on an ongoing basis. If you have not already done so, we encourage you to access and peruse the site at www.allsaintsbedford.ca.

The Committee has also developed the terms of reference for a Ways and Means Committee. The role of the committee is to support the Visioning and Discernment Committee and Parish Council in enabling the work of the Church. Specifically, the committee will seek to identify potential fundraising activities to support the financial needs of the Parish. A Parish wide email was issued seeking expressions of interest from anyone wishing to serve on this Committee. However, to date, we have had no responses.

Speaking of finances, following are a few highlights from our 2020 fiscal year. Notwithstanding the shut-down due to the pandemic, parishioners maintained their generous contributions, with only a slight (approx 4.4%) decrease in regular income. The Diocese also provided assistance, as it did to all parishes, by paying the Rector's salary, while at the same time waiving allotment payments for several months. Through the Diocese we were also able to claim an amount under the Federal Government wage subsidy. Fundraising and activity income was down primarily due to the cancellation of our lobster and olde fashioned Christmas dinners. As noted in the 2019 annual report, we did have to replace our furnace at a cost of approximately \$10,000.

The above resulted in a net operating deficit of approximately \$11,000, which was significantly less than the \$39,700 projected in our 2020 budget as tabled in the 2019 annual report. Nevertheless, we remain in a deficit position and therefore Council has decided to continue to defer payment of our allotment to the Diocese. However, as noted in the 2019 annual report, in late 2019 we received a bequest of \$27,000, which enabled us this year to pay down the 2018 portion of our allotment arrears. As of 31 December 2020, the total allotment amount owing, was approximately \$58,000.

All Saints exists through the generosity of you our Parishioners, in your regular giving's; and through the support of our fundraising and other events, which we hope to reinstate following the lifting of pandemic restrictions. On behalf of Rev. Trevor, Rev. Shirley and all members of

Parish Council, we thank you for your generosity, your gifts and your participation in fulfilling our Mission Statement.

## **Cemetery Report 2020**

All Saints Cemetery is located at the junction of Perth and Wardour Streets. The cemetery is intended for the use by any member of All Saints Church, any member of the Anglican Community of the town of Bedford and any past supporting member of our parish regardless of current place of residence.

When a burial lot is purchased a "conveyance" is provided in the name of the purchaser, this is the deed to the lot. The conveyance stipulates regulations pertaining to the use of the lot and general information regarding the responsibilities of the purchaser and of All Saints Church. Perpetual care for each burial lot is included in the purchase price. Perpetual care provides for the ongoing maintenance of the burial lot and cemetery grounds. Fifty percent of the purchase price of a burial lot is forwarded to the "Grave Lot Fund" which is controlled by the diocese. This is a mutual investment fund that provides a dividend to the cemetery twice a year. The other half of the burial lot price is used for maintenance, repairs and improvements for the cemetery.

The cemetery is not responsible for the maintenance or repairs to any tombstone or markers on the burial lot. Lot owners and visitors are encouraged not to leave waste and debris on the cemetery grounds or near the shed as we do not have a waste or compost removal program in place.

## **Activities**

For the 2020 season we received a grant from Service Canada's Summer Jobs Program allowing us to hire a student to maintain the cemetery and church property

## Strategic Planning/Visioning/Discernment Committee Report, 2020

The Visioning Committee is a subgroup of Council. Its members include Amada Avery, Candice Chapman, Liz Legere, Sharron Burrows, Clarence Hewitt, Lindsay Lamb, Ruth MacNeil, Fred French and Reverend Trevor.

Major activities during the past year included:

- -development and implementation of a Parish-wide survey, distributed both electronically and in hard copy
- -creation of a new, modernized and dynamic website
- -creation of a Ways & Means Committee, intended to assist the church with financial stability
- -with Council's approval, acquisition and installation of upgraded audiovisual equipment to allow for online live streaming of services and church events

The overarching theme of the work of this Committee is to define and assist in implementing the mission of our church. In doing so, and with reference to the results of the survey, we envision All Saints as resting on four organizational pillars: mission, mentoring, financial stewardship and communication. Our activities outlined above fall into one or more of the organizational pillars and the pillars require us to focus not only inward but out to the larger community.

As we move into 2021, we continue to ask questions: how do we make the most of our time, treasure and talents? How do we increase our visibility in the community? How accessible should we be? How do we fulfil our mission with limited resources? What does it mean to be an invitational community? To be spiritually radical? Radical in our hospitality? What type of worship services best meet the needs of our community? We welcome input from anyone who would like to share their own thoughts on these critical enquiries. We are contemplating focus groups and interviews to aid our exploration of these questions and to assist our listening within the greater Bedford community.

Expressions of interest in joining the Ways & Means Committee are welcome.

# ALL SAINTS PARISH, BEDFORD A VISION FOR THE FUTURE

# SUMMARY OF MAJOR THEMES EMERGING FROM THE 2020 SURVEY OF PARISH MEMBERS

**Introduction.** During the summer of 2020, the Parish Visioning Committee conducted a survey of Parish members to determine their perceptions of how the Parish was currently performing and their perceptions of the proposed mission and values statement. The intent was to use the information gained in the survey along with other information to document areas in which the Parish was doing well and any areas in which the Parish could improve its overall performance. The survey work was undertaken with the volunteer support of Dr. Fred French and Ms. Alexandra French members of All Saints Parish who have expertise in survey research and data analysis. The survey was reviewed, revised and approved by the Visioning Committee. All information gathered was confidential with participants not being identified. Data was gathered using an online survey package. As well, hard copies of the survey were completed by those without online access and returned to the church office.

A total of 65 members of the Parish responded to the survey. The number of responses represents a strong participation rate which is useful for insight into the views of parishioners.

Of the 65 respondents, 71.9% were female and 29.1% were male. As well, 86% were over 60; 8.5% were between 46-60, and 5.1% were between 31-45. The majority of the parishioners were from Bedford (77.9%) with 10.1% from Halifax and 8.6% from Dartmouth.

## Key Themes.

**Spiritual Direction & Ministry ...** Generally, respondents indicated agreement with the spiritual direction of All Saints. However, relative to the spiritual direction of All Saints, respondents indicated a need to pay more attention to younger persons, members from diverse racial backgrounds, widows, seniors and those who identified as LGBTQ.

**Worship Services** ... While respondents were in general agreement that they were satisfied with the format and content of services, almost 20% of respondents indicated that they would appreciate having more options for service times and various formats available to them particularly something that would be attractive to younger members of the Parish. Some suggestions included shorter services, more options for evening services and about 75% indicated they liked the inclusion of online and tele-ministry services which they indicated should be continued.

**Fiscal Responsibility and Church Management ...** Respondents provided a wide range of opinions on the fiscal picture for All Saints Parish. While approximately 80% of respondents indicated general agreement that All Saints was an organized and viable Parish, concerns where expressed about the lack of new volunteers joining in the work of the Parish, about the direction provided to Priests by Parish Council and the need to enhance the fund raising abilities of the Parish.

Unfortunately, it was unclear as to what was meant by the concern with the direction provided to Priests by Parish Council as approximately 64% indicated that they had 'no opinion' or couldn't respond to this statement. However, a number of respondents in the comment section identified the need for more volunteers to help carry our the work of the Parish and for an improved approach to fund raising.

A significant observation drawn from the responses by participants in the survey was that approximately 30% of respondents indicated that they didn't know how to respond to many of the items in this section of the survey. This tends to indicate a need to address communication to Parish members among other potential initiatives pertinent to this area.

**Communication** ... While there was general agreement that All Saints as a parish communicated with its members in a timely manner, approximately 10% disagreed with this and a little less than 10% stated that they didn't feel their input was valued. Concerns were expressed over the current website and social media presence of the Parish. As well, approximately 41% of respondents stated that they didn't know or didn't agree that the Parish maintained up to date contact information on its parishioners.

**Sense of Community Among Parishioners in All Saints ...** Generally, parishioners provided high levels of agreement (approximately 85% agreement) with statements about the parish being welcoming, inclusive, offering ongoing events that encourage participation and a sense of belonging, and, the leadership team actively support activities. As well, Parish Priests were viewed as creating a climate of acceptance. Over 80% stated that they felt they had a voice in the parish.

For those who did not agree with these statements, comments indicated that they felt the parish needed to be more inclusive and engaging especially for younger persons, that Priests needed to be more visible at events and that it was difficult to gain acceptance in parish life. Only approximately 56% felt that the parish supported its diocesan responsibilities and that more attention to this area was necessary.

**Community Service** ... Approximately 59% of respondents agreed that All Saints provided organized services to support those in the community who were isolated and/or in need. About 50% agreed that the Parish had a recognized presence in the community. However, approximately 77% indicated that they were familiar with the out-reach programs organized by All Saints while 72% noted that the Parish had organized opportunities to support its ministry.

Comments from respondents helped clarify this apparent discrepancy. In general, it appears that respondents believe the parish could do more to support those who are disadvantaged and in a more organized manner. Respondents indicated that communication about community activities was limited and that newer member did not have the same opportunities to participate. One person perhaps captured the general view of those with concerns in stating that, 'All Saints had a very low profile in Bedford compared to the other churches in the community'. However, to balance that view, another respondent stated that, 'the parish did fantastic outreach for its size'.

**Physical Facilities** ... A little over 65% of respondents stated that All Saints was in good repair and met Parish needs while approximately 87% stated that they believed the church building and grounds were well maintained. As well, slightly over 85% of respondents stated that they

believed All Saints facilities were used in an appropriate manner providing community supports to groups such as AA, Scouts and others.

A variety of opinions were expressed by respondents regarding the facilities ranging from how peaceful the church felt and that they would not like to see if modernized while others felt it needed a facelift. There was general agreement that while the parish had financial constraints there was a need to address the condition of the parking lot which was described as unsafe and needing pavement.

**Comments in Open Ended Questions ...** There were a range of comments in the open ended questions that followed the rating section of the survey. The following themes emerged:

- The church was perceived as welcoming, caring and met the spiritual needs of respondents. As well, in general there was effective leadership in the Parish.
- A variety of respondents stated that the parish had strong support from seniors but needed to work to attract younger members.
- The Parish through its ministry and its Priests needed to be more visible and proactive in the broader community.
- While a variety of respondents stated that they felt the parish was doing well the way it was, there were a number of suggestions for improvement. These broke down into themes that reflected:
  - 1. increased availability of more services in evenings during the week with more uplifting music;
  - 2. improved communications and greater use of social media;
  - 3. greater engagement in the wider community by all including the priest
  - 4. continued action on encouraging greater diversity in the Church community particularly among youth and families/individuals from diverse backgrounds with specific attention to newcomers to the community;
  - 5. sponsoring early childhood support;
  - 6. broadening seniors activities;
  - 7. providing increased support for persons who are disadvantaged.

Comments regarding the Mission & Core Values Statements ... A variety of diverse opinions were expressed regarding the mission and core values statements that have been proposed. While there was generally little commentary on the mission and values statements, it tended to split between persons who liked the statements and those who were seeking improvements. The suggestions for improvement tended to speak to statements about trying to link the mission to specific actions oriented around inclusivity and vibrancy. With regard to the core values statements, the suggestions for improvement tended to focus on the need for the statements to move beyond what to some appeared to be cliché statements to be more action-oriented statements. As well, there was some consensus that more needed to be actioned about stewardship, inclusion and diversity with the result being a greater embodiment of the mission and values in day to day action items that went beyond the written word. While a number felt the mission and values were evident in the church, it was agreed by most that these should be actively monitored and improved on a continual basis.

## ALL SAINTS MINISTRIES

## Lay Ministers Report

One of the most visible aspects of serving as Lay Minister is the service they offer during our worship services at both 8am and 10am. Lay Ministers, and those in training, attend the Altar as servers, crucifers and as MC's. From time to time they might also lead Morning or Evening Prayer services. Several of our Lay Ministers have shared their reflections or a homily during sermon time. Their presence adds so much to our worship.

A ministry which is less visible to the congregation, but visible nonetheless, is assisting with Home Communions and liturgies at the Berkeley and Ivany Place.

But our Lay Readers, and those in training, are also busy behind the scenes. Some of their many ministries include participating on the Worship Committee, writing the Prayers of the People, and leading or co-leading Messy Church, Bible Studies, Christian Meditation and our summer Walks in the Park.

## **Altar Guild Report 2020**

Our group prepares the altar for Sunday services, and provides flowers for special worship services.

The past year has been challenging because of the Covid 19 virus and the restrictions on having church services. As a consequence, very few services were held at the church and thanks to Reverend Trevor for preparing the elements when required.

We still continue to seek new members for the Guild. If you have the time and the interest, and wish to help your church, please consider becoming a Guild member. We work in pairs for a two week period on a rotational basis. Our work involves placing the elements of communion (bread and wine) on the altar for each service, the periodic changing of the hangings, placement of flowers, and ensuring the candles are fueled. If you are interested, please contact myself or Reverend Trevor. There is training available, and you will always work with an experienced member of the team.

If you are considering a gift to the church, please consider the Altar Guild for your donation so we may continue to replace the elements used in the Eucharist.

## **OUTREACH**

## St. George's Dinner Report 2020

St .George's Church, [the round church], operates a Soup Kitchen out of their parish hall. Every Saturday a full hot meal is served to some of the most vulnerable people in our city. This service is facilitated by a core group from St. George's and rotating groups from various churches and service organizations in HRM. In 2020 All Saints, Bedford, participated three times - in March, June and October.

Under normal circumstances, we had a team of 20 - 25 parishioners – young, old and in between who gave generously of their time and talents to help in this outreach program. They shopped for and distributed the pie ingredients, made Shepherd's pie, transported them to St. George's, served dinner, and helped set up/clean up of the hall. Our biggest reward was a "thank you" from the dinner guests.

Our cost for providing dinner is approximately \$300 - \$400.00 each time. We have received several monetary donations and grocery store gift cards from our church family. The Atlantic Superstore has reduced their financial support from \$300.00 x 3 times a year to \$100.00 once a year. All donations received help this community outreach program to function.

On March 7 we served 100+ persons at the soup kitchen. Any leftovers were delivered to Metro Turning Point. The following week the COVID 19 pandemic restrictions were put in place- we had lockdown and shutdown. Our churches were closed and we were asked to stay the blazes home! These new protocols also prohibited St. George's from serving meals inside therefore the Soup Kitchen was required to do "take out" only. We were scheduled to be there on June 6 but after discussion the committee decided that we could not ask parishioners to volunteer for June. However, cognizant of the continued need to feed the hungry we looked for an alternative way to support St.George's. Generally it costs \$300 -400.00 to provide the ingredients for the Shepherd's pies. With this figure in mind we asked for approval to have a cheque for \$300.00 sent to the Soup Kitchen. This was done and appreciated by St. George's.

By September some of the restrictions had been lifted and it was felt that we would be able to provide pies and helpers for our scheduled Oct 17 date. Because churches were still closed we had no "sign up" sheets therefore it was more difficult to find volunteers. However, on Oct.17 we were able to provide 7 pies and 4 volunteers who helped serve up 117 "take out" meals. There were no leftovers.

At the present time there are gift cards [for Superstore] valued at \$189.78 + \$8.00 cash + church treasury \$416.12 which gives a total of \$613.90. As previously noted the annual donation from the Superstore has been decreased by \$800.00. With this in mind we hope that parishioners will consider making a donation to the St. George's dinner fund – either with dollars or with a Superstore gift card. Your continued support of this worthy outreach program is greatly appreciated. Your time and dollars are well spent.

Many thanks to all of those who were part of the All Saints, Bedford team – a job well done! Please mark on your 2021 calendars – ST. GEORGE'S DINNER -MARCH 6 - May 29 and OCTOBER 16. With your help we can help feed the hungry one meal at a time.

Less than a week after closing night of *Jitters!*, we all found ourselves in a lockdown due to the rapid rise of Covid cases in our province. Overnight, all our usual theatre activities came to an abrupt halt. As the pandemic continued, Bedford Players was forced to call off both our June 2020 and November 2020 productions.

Despite this, the BP Executive Council continued to meet each month, moving to an online platform. As well, we were able to continue to offer our monthly play reads online, with a "trial run" in May and June. In the fall, with a low Covid case count and the easing of restrictions in the province, we were able to offer the September and October play reads in person. These were held in the church hall in strict adherence to all Covid protocols. We were very grateful to the church for opening your premises to us during that time. However, as the case numbers began to climb again in NS and further restrictions were put in place by Public Health, we moved the monthly play reads back online. We're pleased that each play read, whether in person or online, has brought new people to Bedford Players. Many of these folks have expressed a keen interest in volunteering with us once it's safe for our productions to start up again.

Over the Christmas season, Bedford Players began to sell gift certificates to future shows. We had good response to this offer and have decided to continue to sell those gift certificates into 2021. The funds realized from those sales will go toward the expenses we will have to incur in staging our first play post-pandemic. ## Notes to the December 31, 2020 Financial Statements

## **I.GIVING INCOME:** 14.8% Decrease 2019/2020

While weekly Offerings and appeal donations Increased the remainder of giving income decreased In total Giving's fell to \$126,977 this period from \$149,129 in fiscal 2019\* This decrease was largely a result of funds collected for the 150<sup>th</sup> Anniversary (\$7,602) in 2019 a single event for that period not returning in 2020. Another factor adding to the decrease was either or limited capacity of church activities/facilities beginning in March and continuing to the end of 2020.

In fiscal 2019 donations from Canada Helps were reported as Gift income whereas in 2020 donations received through that source were reported as weekly giving's. This change was prompted by the fact the majority of funds were from parishioners utilizing the service to maintain their weekly giving's.

Initial Offering & Loose collection declined \$1,905 solely due to closure of in-person church services. Also the decline year/year of \$2,490 for Lent/Easter Thanksgiving/Advent & Christmas services was entirely a result of the Covid19 pandemic shutdown.

#### 2, OPERATING INCOME: 16.5% Decrease 2019/2020

Added to giving Income are revenues from raising activities, rentals, investment income and Bedford Players. Not surprising revenues from those sources decline \$13,079 (33%) in fiscal 2020 due mainly to the impact of Covid19. In 2019 revenues from the annual lobster supper and the OFCD were \$8,434 as compared to 2020 when \$4,006 was collected. Rental income declining \$2,211.

Financial assistance in 2020 from Bedford Players reduced to \$6,000. from \$8560. a year earlier.

# 3: PAYROLL Expense: 21.7% Decrease 2019/2020

Diocese paid clergy remuneration for Apr, May and part of June for total of \$18,765

For the months of July to December we received \$6,507 from CEWS (Canadian Employee Wage Subsidy) program designed to assist small business and non-profit organizations experiencing reduced incomes due to the pandemic:

In total payroll assistance from the Diocese and CEWS amounted to \$25,272.

#### UTILITIES: 23.5% Decline 2019/2020

Utility costs declined sharply in 2020 due to the facilities not being used as much as in the previous year.

#### 5 Allotment Fiscal 2020 \$2,577 PIM:

Allotment arrears was paid down \$24,806 from proceeds received in 2019 from a bequest. Additionally, the Diocese waived allotment payments for the three months of March to May in the amount of \$7,731. The remaining amounts were accrued, as in previous years, in order to conserve cash for church operations. The current outstanding amount owing is \$57,075.

Allotment Payments have been increased to \$3,004 for fiscal 2021.

## **6. OPERATING SURPLUS/DEFICIT:**

Operating Expenses exceeded our Operating Income by \$ 13,287. In fiscal 2020 the parish was fortunate to have had financial assistance from the Diocese to the extent of \$26,496 which effectively reduced the overall deficit as compared to the past two fiscal periods.

With the uncertainty continuing with Covid19 pandemic fiscal 2021 may well be another challenging year. There is no certainty the Diocese or the continuation of Government assistance will be evident and as such we have projected an operating deficit of \$42, 707

## 7. CAPITAL EXPENDITURES:

Each year we require a base amount just to keep the physical assets repaired. In 2020 we spent \$10,454 to replace the furnace, purchase audiovisual equipment to permit church services to be streamed on-line and constructed a new more efficient web-site

To finance those expenditures Council decided to cash three small investment accounts held at the Diocese totalling \$10,249 Further assistance was requested through a special appeal for the purchase of the new furnace. This appeal resulted in donations of \$3,512.

## 8. CASH FLOW:

This is the net amount remaining from Operating Income. After paying regular expenses & capital expenditures and receiving a grant and cancelling investments a deficit cash flow of (\$9,978) was recorded.

# <u>Assumptions — Budget 2021</u>

## INCOME:

For fiscal 2021 we have prepared the forecast to be slightly above last year's level, to \$130,550 an increase of 2.8% While cautiously optimistic regular in person worship will resume during 2021 it will, in all probability, be late in the year.

Advent/Christmas: considering vaccines to fight Covid19 currently being distributed, we are hopeful, by this time next year church activities and services will becoming more normalized. We are therefore projecting revenues to be more in line with the amounts reported in fiscal 2019. Fiscal 2020 was not indicative of a normal Advent/Christmas period.

Bedford Players \$6000 Donations from Bedford Players will be significantly reduced in fiscal 2021 due to ongoing affects of Covid19 negatively impacting their ability to produce events. We have therefore budgeted or a small donation late in fiscal 2021.

Hall & Parking Lot: projected increase is in anticipation of a new lease with a tenant of Drummond Investments Ltd for 3-4 parking sites in the upper parking lot.

Fund Raising Projects: We optimistic, with the roll out of vaccines to combat Covid19 virus, fiscal 2021 will bring normalization to church activities and as a result we are projecting the following:

#### **Expenses:**

An increase of 8% to annual premiums as advised by the Diocese.

We are budgeting "Total Utilities" to remain in line with fiscal 2020

Allotment payments have been increased from \$2,577 to \$3,004 (+9.0%) as advised by the Diocese. The 2021 Allotment has been established based upon fiscal 2019 financial results.

Budgeted reductions in "Offce & Admin" totalling \$1,850 results from (a) the decision not to re-order parishioners envelopes for 2021 a saving of \$676.(b) HST of \$658.paid on the new furnace purchase (c) a fee of \$386 for the development of our new website will not be required this fiscal period.

Payroll \$124,024 an increase of \$29,766 Since March 2020 the parish payroll received significant assistance from the Diocese and through The Federal Government CEWS program. There is no assurance this assistance will continue into fiscal 2021 and the budget was prepared accordingly.

An allocation of \$5,000 for Capital Expenditures will allow for the replacement of several windows as well as a new door on the north side of the church towards Cliff Street. Additionally a small amount of painting will be completed later in this fiscal period.

# Operating Surplus/Deficit

Although receiving substantial assistance in 2020 from the Diocese and CEWS program a deficit of \$13,287 was reported Since there are no assurances this assistance will continue the 2021 Budget has been prepared based upon Income remaining slightly about, the 2020 level and Expenses returning to the 2019 level. Under those assumptions a deficit of \$42,707 is budgeted.
